These forums provide a venue for top executives to learn from each other and promote better business practices across the industry. These Councils, Committees, and Working Groups are exclusive to NH&RA members.

ASSET MANAGEMENT COUNCIL

This council focuses on creating enterprise value for owners and investors of affordable housing through the development of asset management best practices. The council focuses on an array of topics including organizational benchmarking, utility efficiency, disposition and recapitalization best practices, portfolio management and risk mitigation with an emphasis on creating value and fostering collaboration. The Asset Management Council also hosts NH&RA's Council on Energy Friendly Affordable Housing, a working group of owners, managers, and consultants dedicated to improving the energy performance of the existing LIHTC and HUD-assisted housing portfolio while encouraging policies that support sustainable development.
