



Affordable Housing Shortage

Housing is generally considered affordable when it consumes less than 30 percent of household income.

NATIONALLY

Prior to the COVID-19 crisis, nearly 11 million renter households (one in four) were spending more than half of their income on rent, leaving little room for other necessities like medicine, childcare, and healthy food.

NEW YORK

In New York in 2017, housing costs for nearly 2.8 million of the state's 7.3 million households, including almost half of all rental households and more than one in four homeowners, exceeded the affordability threshold, according to U.S. Census Bureau data. Within this group, nearly 1.4 million households were considered severely burdened by housing costs that consumed half or more of their income.

Legislative Solutions

New York's Housing Our Neighbors with Dignity act (HONDA)

WHAT IT DOES:

Enacts the "[Housing Our Neighbors with Dignity Act](#)" in order to provide a mechanism for the state to finance the acquisition of distressed hotels and commercial office properties by the appropriate nonprofit organizations for the purpose of maintaining or increasing affordable housing.

IT'S IMPACT:

Will allow more projects like Park 79 to become a reality.
