Dear Leader Schumer and Leader McConnell:

The undersigned 120 leading national and statewide affordable housing and community development organizations strongly support the investment in critically needed affordable housing supply in the bipartisan, bicameral Tax Relief for American Families and Workers Act (the Act), which the House of Representatives passed January 31 with wide bipartisan support. We urge you to take up this bill in the Senate as soon as possible.

America has been in the midst of a housing crisis for a long time, but never has it been more acute than it is now, particularly for low-income families, seniors on fixed incomes, people with disabilities and other vulnerable populations. Since the Great Recession, our nation has drastically under-built rental housing, while at the same time the population of renters has grown significantly. According to the Joint Center for Housing Studies at Harvard University, the number of renter households grew by 1.1 million to 44.2 million just in the time between early 2020 and early 2022. We are currently seeing the repercussions of this extreme mismatch between supply and demand, with critically low vacancy rates and rents that in recent years have grown far faster than incomes.

The affordable housing provisions in the Act build on what we know works: the Low-Income Housing Tax Credit (Housing Credit) program. For nearly 40 years, the Housing Credit has been our nation's most essential housing production program, relying on a public-private partnership model that transfers risk away from the taxpayer to the private sector.

The standalone legislation that inspired the housing provisions in the Act, the Affordable Housing Credit Improvement Act (S.1557 / H.R. 3238), Sponsored by Senators Maria Cantwell (D-WA), Todd Young (R-IN), Ron Wyden (D-OR), and Marsha Blackburn (R-TN) in the Senate and Representatives Darin LaHood (R-IL), Suzan DelBene (D-WA), Brad Wenstrup (R-OH), Don Beyer (D-VA), Claudia Tenney (R-NY), and Jimmy Panetta (D-CA) in the House has the support of nearly half of Congress. What's more, that support is evenly divided between Republicans and Democrats in both chambers.

The affordable housing provisions in the Act would result in the production and preservation of over 200,000 additional rental homes for low-income households. They would also support over 300,000 jobs, generate approximately \$34.3 billion in wages and business income, and result in approximately \$11.9 billion in federal, state, and local tax revenue. While the Act alone does not solve the housing crisis, it is a huge step in the right direction at a time when these resources are desperately needed. The demand and the capacity are there, with shovel-ready, would-be housing developments just waiting for these resources.

We thank you for your leadership and urge the Senate to move forward with consideration of the bill and enact its affordable housing provisions so that state Housing Credit Agencies and their

partners in the affordable housing industry can begin to turn the resources these tax changes would unlock into affordable rental homes for people in need.
